

Social Work and Social Care - A cut too far Has Edinburgh learned nothing?

UNISON has grave concerns and is challenging the proposed cuts to the management arrangements in the Services to Children and Young People.

The proposals include further cuts to Social Work Practice Teams, Children's Residential Care, Through Care and After Care, Young Peoples Service, and the future of Family Based Care is uncertain.

To compound this we are due to witness the biggest cuts Edinburgh has ever seen in support staff resulting in the loss of the essential administration that allows social work staff to get on with their job and provides the failsafe backup for child care and protection.

These proposed cuts will have a significant impact on the delivery of the services provided to the most vulnerable and disadvantaged Children and families in our City.

Year on year cuts have already left our members in these services greatly overstretched.

Our members are continually worried about their futures, the professional management support that they rely on, and the services that they provide to service users. The risks to staff, our Service Users, and the City Council, are too great to allow any of these cuts

We will not allow our members to be continually overburdened, or placed at risk, due to the short-sightedness of management and elected members.
